End User Licence Agreement (EULA)

Effective Date: April 2026

PLEASE READ THIS END USER LICENCE AGREEMENT CAREFULLY BEFORE INSTALLING OR USING PULSE. BY INSTALLING, COPYING, OR OTHERWISE USING THIS SOFTWARE, YOU AGREE TO BE BOUND BY THE TERMS OF THIS AGREEMENT. IF YOU DO NOT AGREE, DO NOT INSTALL OR USE THE SOFTWARE.

1. Definitions

"**Software**" means the Pulse BIM Health Dashboard application, including all associated files, documentation, updates, and any future versions.

"**Licensor**" means the individual or entity that developed and distributes Pulse (contact: garth.hsu@gmail.com).

"**Licensee**" / "**You**" means the individual or organisation that has accepted this Agreement and is accessing or using the Software.

"**Autodesk Platform**" means Autodesk Revit and related services through which the Software operates.

2. Grant of Licence

Subject to the terms of this Agreement and payment of any applicable fees, the Licensor grants You a limited, non-exclusive, non-transferable, revocable licence to:

- (a) Install and use the Software on devices You own or control for Your internal business purposes;
- (b) Use the Software solely in conjunction with a licensed copy of Autodesk Revit 2025 and/or 2026.

This licence does not include the right to sublicense, resell, redistribute, or otherwise transfer the Software to any third party.

3. Subscription and Trial Period

The Software may be offered under a free trial period or paid subscription model as specified on the Autodesk App Store listing at the time of purchase. Continued use after the trial period requires a valid, active subscription purchased through the Autodesk App Store. The Licensor reserves the right to modify pricing and subscription terms with reasonable prior notice.

4. Restrictions

You must not:

- (a) Copy, modify, adapt, translate, or create derivative works of the Software;

- (b) Reverse engineer, decompile, disassemble, or attempt to derive the source code of the Software, except to the extent permitted by applicable law;
- (c) Remove, alter, or obscure any proprietary notices, labels, or marks on the Software;
- (d) Use the Software for any unlawful purpose or in violation of any applicable laws or regulations;
- (e) Share, rent, lease, lend, or otherwise make the Software available to any third party;
- (f) Use the Software to develop a competing product or service.

5. Intellectual Property

The Software and all copies thereof are proprietary to the Licensor and title thereto remains with the Licensor. All rights in the Software not specifically granted in this Agreement are reserved to the Licensor. You acknowledge that no title to the intellectual property in the Software is transferred to You.

6. Firm Configuration File

The Software includes a FirmConfig.json file that may be customised by the Licensee for internal firm use (e.g., check weightings and thresholds). Such customisation does not constitute a modification of the Software for the purposes of Section 4 and is expressly permitted. The Licensor accepts no liability for any errors arising from incorrect configuration by the Licensee.

7. Data and Privacy

The Software transmits Your Autodesk Login User ID solely to the Autodesk Entitlement API for the purpose of verifying Your active licence. No project data, model content, or personal information beyond the User ID is collected, stored, or transmitted by the Licensor. Please refer to the Pulse Privacy Policy for full details.

8. Updates and Support

The Licensor may, at its sole discretion, issue updates, patches, or new versions of the Software. Such updates may be provided automatically through the Autodesk App Store. The Licensor has no obligation to provide updates, maintenance, or technical support unless expressly agreed in writing. Support enquiries may be directed to garth.hsu@gmail.com.

This Agreement shall be governed by and construed in accordance with the laws of New South Wales, Australia, without regard to its conflict of law provisions. Any disputes arising under this Agreement shall be subject to the exclusive jurisdiction of the courts of New South Wales, Australia.

14. Severability

If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

15. Entire Agreement

This Agreement, together with the Pulse Privacy Policy, constitutes the entire agreement between You and the Licensor with respect to the Software and supersedes all prior or contemporaneous understandings, agreements, negotiations, representations, and warranties, whether written or oral.
